Safety First: Face Masks Required

We are very excited to welcome our students and staff back for the 2021-2022 school year and return to five days a week of in-person learning starting September 8.

In accordance with Governor Carney's recent announcement, the recommendation of the CDC, and in order to help prevent the spread of the coronavirus, Newark High School will follow the Governor's guidance and require face masks to be worn by all staff and students regardless of vaccination status.

The face mask requirement applies to all indoor settings, including schools, school district facilities, and school buses. Vaccination and Antigen Consent Form

As we move forward into the 2021-2022 school year, we are excited to be together in schools across the state. We know the past year has been incredibly challenging and we are grateful for your continued collaboration as we enter the next phase of the pandemic – one that hopefully leads us back to safe, healthy, and supportive school environments for all students.

To ensure that we return in a way that is both safe and allows for us to all learn together, we hope that you, if you have not done so already, consider being vaccinated and ensuring that your student, if eligible, is also vaccinated before the beginning of the school year. Information on the <u>vaccine for children 12-17 years old</u> can be found on the Delaware Division of Public Health (DPH) website and locations with available vaccine can be found <u>here</u>. All available COVID-19 vaccines, including the Pfizer vaccine approved specifically for individuals 12-17, provide a high level of protection and are extremely safe in all populations.





Getting more of our high school students partially or fully vaccinated prior to starting the 2021-2022 school year will cut back on the chance that COVID-19 will spread in our school and once again disrupt learning. Children are at risk for illness *and* hospitalization from COVID-19; and the Delta variant, which is the predominant strain now in Delaware, spreads more easily among unvaccinated persons.

Individuals are "fully vaccinated" two weeks after their second dose of the Pfizer or Moderna vaccine or after one dose of the Johnson & Johnson vaccine. As such, we encourage you to come on August 19th or to access the vaccine sooner at a nearby <u>pharmacy</u>, <u>DPH clinic</u>, <u>primary care provider office</u>, <u>or community site</u>, to allow enough time for second doses to be delivered and increase the percentage of fully vaccinated eligible individuals in our schools. Individuals and students who are not eligible for vaccination and/or choose not to be vaccinated should complete the Antigen testing consent form, <u>HERE</u> (*please see our CSD website for active links*). This will allow your child to be screened for the presence of the COVID-19 virus weekly, while at school. Technology 1:1

The Christina School District (CSD) has invested in a 1:1 technology initiative for students. The initiative is meant to increase student access to technology, improve writing skills, boost motivation and engagement and foster the development of 21st-century skills through project development, research and communication. It is critical that our students be technology literate as they work toward becoming college and career ready. Students will use their devices in and out of the classroom to perform research, complete projects, submit assignments, and take assessments.

All students will be assigned a Chromebook and charger that they will utilize for the academic school year.

Prior to being assigned a device, students and families will be required to sign the 1:1 Technology Initiative Agreement. Once the signed form has been collected, your child will be assigned his/her 1:1 device. We are very excited about the 1:1 technology initiative. Our students will utilize their devices as a tool to improve learning, manage time, organize documents, and share information. Additional information and the technology documents will be provided at the beginning of the year.

Visitors

All visitors are required to register at the desk in the Main Office upon arriving at the school, at which time a Visitor pass will be issued for wearing. Students are not permitted to "shadow" registered students. The school arranges periodic tours for students and their parents. Contact the main office for dates and times.

Yellowjacket Sports

Newark High School (NHS) has a long and successful tradition of team sports, with both junior varsity and varsity programs available for most sports. We are proud of our outstanding athletes, many of whom are recruited by major college teams and earn competitive college scholarships. NHS is a member of the Delaware Interscholastic Athletic Association (DIAA), and follows strict guidelines for athletic eligibility. Sports opportunities may include the following:

- Winter: Basketball, Cheerleading, Indoor Track, Swimming, Wrestling
- Spring: Baseball, Golf, Lacrosse, Soccer, Softball, Tennis, Track/Field

NHS Dress Code

- Face Masks are Required at all times
- Headwear of any type may not be worn male and female. (Note: The only exception to this rule is documented religious or medical reasons) Students are not allowed to carry their hats in their hand throughout the day.
- All clothing must be neat, clean and in a condition of good repair.
- Shorts and skirts are acceptable attire; however they must be an appropriate length in the front, sides and back.
- All shirts must cover shoulders, cleavage, stomach and back.
- Pants must be worn properly and are to be pulled up and secured at the waist. Visible holes above the knee that expose skin are not permitted.
- Footwear must be worn at all times. (bedroom slippers are not permitted)
- Clothing must be worn as intended:
 - No undergarments may be visible at any time.
 - Pajamas are not permitted.
 - Revealing clothing designed to be worn as undergarments cannot be visible.
- Excessively tight clothing is not permitted.
- Students may not wear any garment that would be considered a distraction.
- Apparel that advertises, glorifies, or symbolizes any illegal substances or any substances illegal to minors, containing derogatory phrases, profanity, or glorifies violence or criminal behavior are not permitted to be worn.
- Students may not wear spiked jewelry, long chains or lewd and suggestive clothing.
- No On-Ear & Over-Ear Headphones are permitted (Beats, Sennheiser, Bose, etc.). Only earbud headphones are permitted to be worn only one ear is permitted to be used for the earbud. One ear must always be left earbud free.
- Building Administration will have the final say on the acceptability of student dress.





Cell Phone and Electronic Device Policy

All cell phones and electronic devices (i.e. iPod, smart phone) must be turned off and kept in backpacks/secured pockets during class time. They must NOT be used during class time, unless instructed for use by the teacher. When allowed, students must follow all classroom/hallway rules for the use of a cell phone or electronic device. Cell phones used for other functions (i.e. social media, texting, video, taking pictures etc.) during this time is considered a violation of this Cell Phone and Electronic Device Policy. Students may possess or use personal electronic devices on school property, on school buses, or at school-sponsored events according to the following guidelines:

- Before school until the beginning of the school day
- During a student's lunch period
- After school
- Personal electronic devices may not be used to cause any disruption in the educational process or for unethical or illegal purposes. Prohibited uses include, but are not limited to, cheating on assignments and/or tests, harassing or bullying others, and taking or distributing unauthorized photographs or recordings of other people.
- Personal electronic devices may not be used to access any obscene, threatening or otherwise inappropriate material via any form of electronic communication.
- Personal electronic devices may not be used for any activity prohibited by the CSD Student Manual, to circumvent CSD network security or for any unauthorized access to or inappropriate use of the CSD computer network.
- No On-Ear & Over-Ear Headphones are permitted (Beats, Sennheiser, Sony, Bose, etc.). Only earbud headphones are permitted to be worn only one ear is permitted to be used for the earbud. *One ear must always be left earbud free*.
- The classroom teacher, paraprofessional, substitute, Administration, or other school employee has the final say on cell phone use within the classroom.

CSD/NHS will not be responsible, or liable for, the theft, loss, data loss, damage, destruction, misuse or vandalism of any student's personal electronic device brought onto CSD property. Students in violation of this policy may have their cell phones confiscated and returned only to a parent/guardian regardless of the students' age.
