



## **Title I School Parental Involvement Policy**

1. Newark High School will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:

Newark High School will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend.   - a. *Sending a parent link home informing families of the meeting place and time*
  - b. *Posting the meeting date on the school website*
  - c. *Advertising in the PTA Facebook page*
4. Newark High School will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
  - a. *Sharing information at PTSA in the fall*
  - b. *Holding parent conference days and evenings at minimum twice per year*
  - c. *Publishing interim reports and report card grades*
  - d. *Communicating availability of PSAT link reports with students*
  - e. *Sharing links to the district's curriculum website via our school's website*
5. Newark High School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
  - a. *Parental input is encouraged at every PTA meeting*
  - b. *Parents are encouraged to attend open house, parent conference days, and always request additional conference time with teachers and counselors*
  - c. *Guidance counselors and educational diagnosticians call parents regularly, requesting meetings when necessary.*
6. Newark High School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:



- a. Students and parents receive SAT reports directly from the College Board*
  - b. Students receive PSAT links to reports and are asked to share them with parents*
  
7. Newark High School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
  - a. Parent notification via Schoology*
  
8. Newark High School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph:
  - a. the state's academic content standards,*
  - b. the state's student academic achievement standards,*
  - c. the state and local academic assessments including alternate assessments,*
  - d. the requirements of Part A,*
  - e. how to monitor their child's progress, and*
  - f. how to work with educators:*
    - i. Parent engagement committee events, open house, and parent conferences provide opportunities for the above to take place.*
  
9. Newark High School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
  - a. Providing parents with locations of trainings, when offered*
  - b. Creating a Parent Engagement Committee*
  - c. Linking parents with necessary support programs in the community*
  
10. Newark High School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - a. Creating a city outreach position for a current staff member*
  - b. Holding a new student orientation meeting in the city at the start of the school year*
  - c. Holding regular PTA meetings*
  - d. Maintain the position of an attendance resource officer in the building*
  
11. Newark High School will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
  
12. Newark High School will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:



- a. *Student information regularly sent home*
- b. *Parents receive a regular update, via email, social media, or phone, from the Principal*
- c. *Provide translation support when needed in parent meetings*
- d. *Utilize the district resource for translation services (phone calls)*


